

# Terms & Conditions

## #TEAMARDEXNZ PROMOTION

### ARDEX NEW ZEALAND LTD.



1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to New Zealand residents. Employees (and their immediate families) of the Promoter, participating stores and agencies associated with this promotion are ineligible to enter.
