



## SPRING PROMOTION TERMS & CONDITIONS: FREE ROLLER WHEN YOU BUY 2 SETS OF ARDEX WPM 155 15L/20KG & STB TAPE ROLL

1. Promotion is open to customers who purchase two (2) pails of ARDEX WPM 155 15L/20 kg and two (2) STB Tape Rolls from participating stores or direct from ARDEX New Zealand. Employees and immediate families of the 'Promoter' and 'Promotional Partners' are ineligible to enter. Persons must be over the age of 18 to enter.

2. The Promoter reserves the right to verify the validity of entries/claims and to disqualify any entrant who tampers with the entry/claims process or who submits an entry/ claim that is not in accordance with these Conditions of Entry.

3. The Promotion commences on 1 September 2024 and ends 31 October 2024. All entries must be submitted by 14 November 2024. No responsibility accepted for late, lost or misdirected entries.

4. How to Enter:

- Purchase two (2) pails of ARDEX WPM 155 15L/20kg and two (2) STB Tape Rolls. Multiple entries can be made over the promotional period.
- Complete the registration form online and upload your receipt online to verify your purchase.

5. Applies to non-discounted sales only of WPM155 15L/20 kg (40938) and STB Tape Roll (16870) to eligible customers, these are waterproofing customers or installers (reseller customers) purchasing through any reseller.

6. Offer only applies to full price purchases of WPM155 20kg (40938) and STB Tape Roll (16870)

7. Each company can redeem a maximum of 20 rollers, with a limit of 2 rollers per person.

8. Must be a single purchase of two (2) pails and two (2) tape rolls on one invoice

- Copies of invoices will be requested to claim the roller and please note we may contact your distributor to confirm the purchase
- Invoices must be dated 1 September 2024 to 31 October 2024

9. Rollers may be delivered in individual deliveries depending on stock availability. Delivery of rollers to be completed by 14 December 2024

10. Promoters' decision is final, and no correspondence will be entered into.

11. Any costs in excess of the value of the Prizes (if applicable), including GST, and all ancillary costs associated with redeeming the prizes are the responsibility of the winner.

12. The rollers are not exchangeable, not transferable and cannot be taken as cash.
